T. Rowe Price is introducing a new low-cost share class, known as the I Class, for certain equity and fixed income funds. T. Rowe Price is also introducing the Retirement I Funds–I Class, which is a new series and are not separate classes of any of the existing Retirement Funds. The I Class is generally available only to financial intermediaries, other institutional investors, and individuals meeting the investment minimum of \$1 million or certain criteria. While the I Class is not yet available for sale, T. Rowe Price wanted to provide the appropriate CUSIPs in advance to allow our partners to plan appropriately. The equity and fixed income classes listed below went effective with the SEC on August 17, 2015 (and will become publicly available on September 1, 2015), and the Retirement I Funds–I Classes are scheduled to go effective with the SEC on September 25, 2015 (and become publicly available on October 1, 2015). **If you would like to receive a prospectus for the I Class of any of these funds once they become effective with the SEC, please call 1-877-804-2315.
