## Discovery Fund will reopen to new retirement plans and retirement plan platforms

On October 1, 2015, all share classes of the *Wells Fargo Advantage Discovery Fund*<sup>SM</sup> will reopen to new retirement plans and retirement plan platforms. All classes of the fund have been closed to new investors, with certain exceptions detailed in the fund's statement of additional information, since April 2014.

Retirement plans are defined as 401(k) plans, 457 plans, profit sharing and money purchase pension plans, defined benefit plans, target benefit plans, and nonqualified deferred compensation plans.

The following Discovery Fund share classes will be open to new retirement plans and retirement plan platforms as of October 1, 2015:
